DAILY QUESTIONS AND ANSWERS
FROM ARLENE MUNOZ – BUSINESS REPRESENTATIVE
June 25, 2014

Q: Will the teachers cease picketing through the summer months?

A: I hope to announce tomorrow whether the teachers will cease picketing through the summer months. Watch for information regarding Monday, June 30th on tomorrow's post. I am still waiting to hear from School District No. 34 whether or not they are cancelling the Summer School Program for 2014. That announcement should also come tomorrow. Should the District not cancel this program, the teachers will erect pickets at the designated Summer School sites.

I see nothing in the "Essential Service" order by the Labor Board that would include this program. Essential Services covers "emergent" and "disaster" requirements as well as the ability for grades 10 – 12 to partake in Provincial Exams only therefore we could only be forced to cross teacher picket lines for Summer School if so ordered by the Labor Board with an explanation of where that work fits under the essential service order.

Q: "Lost wages" Benefit – when can we expect to get these benefits from Teamsters?

A: Prior to issuing any lost wages benefits an audit of the support staff members who would not have lost wages must be done. A compellation of employees who did not lose wages due to vacation usage, WI benefits, WCB, usage of banked OT, income earned due to being deemed essential services, casuals' inability to complete UFN, etc, must be made. I have been provided with some of the above information and hope that if the support staff is back to work on Monday it will not take long for the District to compile and provide the remaining lists required to complete the task.
